**GRNC Alert 05-05-09:
'Patriot' games: FBI detains North Carolina teen**

As has recently been reported, a North Carolina teen has been dragged from his Oxford, NC home and detained in an Indiana facility for allegedly making bomb threats. Seemingly confirming the fears of opponents of the so-called Patriot Act, the teen was taken in a March 5 raid on his house and sent to the facility far from his home, accused of being a terrorist and has thus far been denied due process of the law. His parents have been allowed only limited access to their son.

GRNC is aware of this situation and is investigating. In the mean time you as North Carolinians and Americans should contact our US Senators and demand an investigation of this.
