Re: Dave Griffith Endorsement

Gentlemen:

By virtue of your blast email sent on April 29, 2014, you have confirmed that you received my letter dated April 26, 2014.

My letter stated that I have worked in the Pistol Permit section for three years. Your "proof" concerning the request for employment information went back three years. My statement is true. How far back do you want to go in your hatchet job?

I am a licensed Concealed Carry Permit holder. My license was issued in February of 2010, which meant that I applied in the winter of 2009. This means that my application was entered during the "required" employment data days to which you have so vigorously offered your objections. When I applied, I had not applied to nor had any contact with the Sheriff's Office or any personnel in that office. Therefore, please explain to me why I did not have to complete an employment disclosure form, and why there is no employment disclosure form in my permanent file. Your bucket does not hold water on this issue.

You further stated that I "admitted" the restricted hours for accepting applications. Is this like "admitting" guilt? Again, you have misstated to serve your purposes. Your new email said that applications are processed between 8:30 AM and 11:30 AM. My letter said "The office adopted a procedure whereby applications are taken from 8:30AM to 11:30 AM each day of the week." My letter went on to explain that the balance of the day is spent in conducting the required steps to process an application. Your statement that processing occurs for only 3 hours per day is another one of your falsehoods, and is intentionally misleading to the public.

I concluded my original letter by stating my interest "...in the fairness of the Political process..." It is obvious that you are more intent on your partisan position, and in attempting to tout your organization "As the most effective gun rights organization in the state..." Your self aggrandizement does not sit well with reasonable people.


